	7.1	<p>PCSO Mike Mann presented the report.</p> <p>Reports of thefts or attempted thefts in Nursling estate. A number at B&Q and these are being investigated. On one occasion 3 men were caught and charged. Catalytic converters were stolen from cars in Oriana Way, an Audi was identified and is being investigated. Diesel was stolen from a site in Test Lane.</p> <p>At Rownhams Services. A group of youths causing a disturbance were moved on and a car seized for having no insurance.</p> <p>On 2 occasions youths were reported fishing in Lakeside Avenue and were moved on.</p> <p>Further nuisance by youths riding motorbikes at Adanac Park.</p> <p>A large group of youths were stopped and spoken to by police and nuisance behaviour (knocking on doors) has since reduced.</p> <p>One report of fly tipping received and another where a horse blanket was stolen. There was damage to a vehicle in Rownhams and a shed was broken into in Nursling.</p> <p>Further reports of theft from the local Co-op.</p> <p>Due to staff cutbacks and re-organisation, only PCSOs will attend Parish Council meetings and even then, not on every occasion as maybe required elsewhere.</p>

Members of the public have until 20th March 2015 to comment.</p> <p>Romsey Sports Centre will still be free to use between 2pm and 4pm every Tuesday during school holidays and half term.</p>	
	8.2	<p>HCC Councillor Roy Perry's Report.</p> <p>Council Tax frozen for 6th year in a row, helped by £5m government grant and part of £12m Conservative funding allocated to children in care.</p> <p>£0.5m grant given to Adult Services to help place elderly patients in care homes to release hospital beds.</p> <p>Between 2014 and 2018 Hampshire to spend £876m on projects such as new schools, extra-care homes, road improvements, broadband. Schools receiving over £300m and a new primary school will be built in Romsey/North Baddesley area.</p> <p>HCC continuing to expand superfast broadband to rural areas and to new large developments eg Abbotswood.</p> <p>HCC changing its 0845 phone numbers to 0300, this should make calls cheaper, depending on phone provider.</p> <p>Flood relief projects and studies in Romsey, Winchester and Basingstoke areas have been speeded up.</p>
