Section 3 – External Auditor’s Report and Certificate 2024/25

In respect of **Nursling And Rownhams Parish Council**

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02 as issued by the NAO on behalf of the Comptroller and Auditor General. AGN 02 is available from the NAO website – <https://www.nao.org.uk/code-audit-practice/guidance-and-information-for-auditors/> .

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

External auditor report 2024/25

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The smaller authority has disclosed that 'There are no matters of actual or potential non compliance with laws, regulations and Proper Practices that could have a significant financial effect on the ability of this authority to conduct its business', by answering 'Yes' to Section 1, Assertion 3. This is inconsistent with the Internal Auditor's response to Internal Control Objective B and L which was answered No

Section 1, Assertion 5 has been incorrectly completed, a review and approval of the risk assessment was not undertaken during the year and therefore should have been answered No. This is inconsistent with the Internal Auditor's response to Internal Control Objective C which was answered No.

The smaller authority has disclosed that it made proper provision during the year 2024/25 for the exercise of public rights, by answering 'Yes' to Section 1, Assertion 4. However, the internal auditor has reported weaknesses in relation to test N as the authority did not publish the external audit report and certificate and the notice of conclusion in relation to the 2023/24 accounts. The authority therefore should have answered 'No' to this assertion.

The smaller authority have answered 'N/a' to AGS Assertion 9 which is incorrect. Evidence has come to our attention to suggest that the smaller authority is a managing trustee, and therefore this should be ticked 'Yes'.

The AGAR has not been completed in accordance with the Accounts and Audit Regulations 2015:

- the minute reference which records the approval of the Annual Governance Statement and Accounting Statements has been entered on Section 1 and Section 2 incorrectly and should read 3.1.

The smaller authority has not provided an adequate explanation for the variance between the prior and current year values in Box 4, 6, and 9 of Section 2.

Other matters not affecting our opinion which we draw to the attention of the authority:

We note that the smaller authority did not comply with Regulation 15 of the Accounts and Audit Regulations 2015 as it failed to make proper provision during the year 2025/26 for the exercise of public rights, since the period for the exercise of public rights was less than 30 consecutive working days in length. As a result, the smaller authority must answer 'No' to Assertion 4 of the Annual Governance Statement for 2025/26 and ensure that it makes proper provision for the exercise of public rights during 2026/27.

The smaller authority has not provided an adequate explanation for the variance between the prior and current year values in Box 3 of Section 2.

The smaller authority's reserves appear excessive as, after accounting for the earmarked reserves, general reserves are greater than annual expenditure. A smaller authority has no specific right to accumulate funds via the precept. The smaller authority should ensure that it has regard to the level of reserves held when considering future precept requests and as part of their annual budgeting process. Any earmarked reserves should also be considered and formally approved by the smaller authority.

The smaller authority does not appear to have a system in place that considers income and expenditure powers when making decisions or payments. The authority need to have robust procedures in place to prevent any decisions or payments being made that are ultra vires.
